## Permit Volume Overview

Chicago issued **1,942 building permits** this month. Express permits — which cover routine electrical, mechanical, and minor alteration work — led volume at **1,203 (61.9%)**. Renovation and alteration permits accounted for **362 (18.6%)**, while ground-up new construction came in at **80 permits (4.1%)**. Demolition activity totaled **42 permits (2.2%)** this period.

## Top Work Categories

Chicago's permit data includes detailed work type classifications that reveal where contractors and tradespeople are most active. The table below shows the six most common work categories issued this month.

## Project Valuation

The combined reported cost of all permitted projects this month totaled **\$513.95 million**, with an average project cost of **\$316,084**. Chicago's construction market spans a wide range — from high-value commercial renovations in the Loop and Near North Side to residential infill and rehab work across the city's neighborhoods. These figures represent contractor-declared valuations at time of permit issuance.

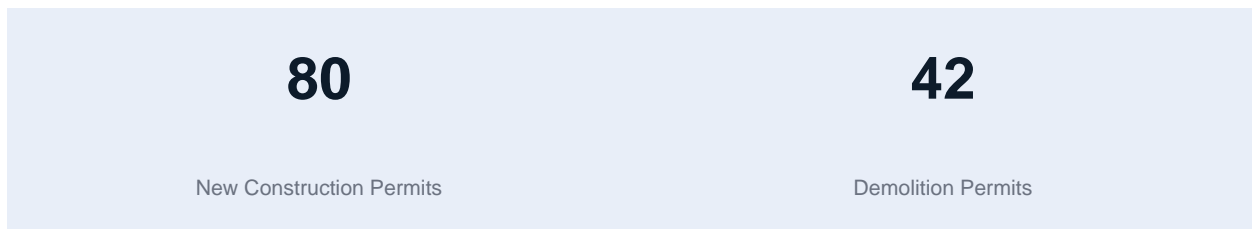
## Community Area Activity

Chicago's 77 community areas offer a clear picture of where construction activity is concentrated. **Loop** led all areas this month with **169 permits** (8.7% of city total). The table below highlights the six most active community areas — a useful guide for contractors targeting specific markets.

## New Construction & Demolition

New construction and demolition permits signal where Chicago's built environment is changing most rapidly. This month, **80 new construction permits** were issued (4.1% of total), covering ground-up residential buildings, commercial developments, and mixed-use projects. Demolition activity — a leading indicator of upcoming new construction — accounted for **42 permits** (2.2%). Together these segments represent some of the highest-value work available to contractors in the market.
